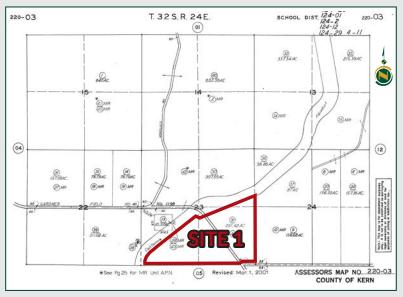


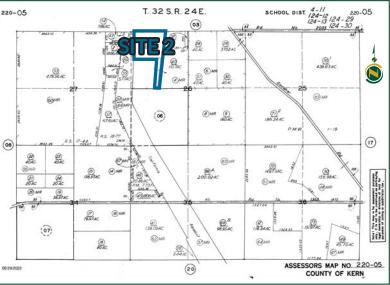
SOILS MAP

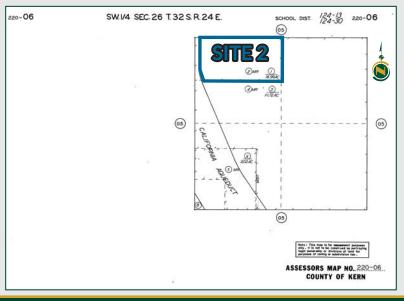




PARCEL MAPS
