### **LEGAL DESCRIPTION**

# Tract 1

Being a 0.5480 acre parcel of land [portions of Lots 28, 29 & 30 as shown on the Plat of Lewisburg, Kentucky, (D.B. 81, page 231)] and being the residence property of Mary M.
