## 270.11 ACRE TRACT

## **Field Notes Description**

Being out of a George R. S. Billups Survey, Abstract 91, Lavaca County, Texas, also being out of a 468.592 acre tract conveyed from Transportation Equipment, Inc to Felix and Oralia Machuca by Cash Warranty Deed dated February 18, 2005 and recorded in Volume 336, Page 293 of the Official Records of Lavaca County, Texas.

Being more fully described by metes and bounds as follows:

**BEGINNING:** at a nail, **(Y = 13,640,255.66, X = 2,684,525.46)**, set in the centerline County Road 14A, and in the southwest line of said 468.592 acre tract, for the westerly southwest corner of this herein described tract;

**THENCE:** N 36°27'02" W -45.74 feet along the centerline of said County Road 14A and the southwest line of this herein described tract to a point at the southwest corner of an 86.449 acre tract conveyed to Migl Properties, LP in Volume 594, Page 863 of the Official Records of Lavaca County, Texas and the northwest corner of said 468.592 acre tract, for the northwest corner of this herein described tract;
