

Deed Records of Hamilton County, Texas, and further described as follows;
BEGINNING, at a 3/8 inch iron rod found in a fence corner, at the Northeast corner of said Wenzel tract,
and being the Northwest corner of a 128.03 acre tract of land that is described in a deed to David
Clayton Tyson, et ux, recorded in Volume 307 at Page 407, said Deed Records, and being in the South
line of a tract of land that is described in a deed to Oscar Melde, recorded in Volume 261 at Page 725,
said Deed Records, for the Northeast corner of this tract;
THENCE, S 18° 47' 56" W 1048.68 feet, with a fence along the East line of said Wenzel tract, and the
West line of said 128.03 acre tract, to a ½ inch iron rod found at the Northeast corner of a 52.73 acre
tract of land that is described in a deed to Zachary Hudson, et ux, recorded in Volume 491 at Page 258,
said Deed Records, for the Southeast corner of this tract;

THENCE, N 22° 01' 27" E 421.79 feet, to a 1 inch iron rod set in the East line of Hamilton County Road Number 404, for the Southwest corner of this iron rod set in the East line of Hamilton County Road Number 404, for the Southwest corner of this

THENCE, N 17° 13' 30" E 478.06 feet, with the East line of Hamilton County Road Number 404, to a 3 inch pipe corner post found in the North line of said Wenzel tract, and being the Southwest corner of a
