

### Information About Brokerage Services

Texas law requires all roal estate licensees to give the following information about brokerage services to prospective buyers, tenants, sellers and landlords.

#### TYPES OF REAL ESTATE LICENSE HOLDERS:

- A BROKER is responsible for all brokerage activities, including acts performed by sales agents sponsored by the broker.
- A SALES AGENT must be sponsored by a broker and works with chemis on behalf of the broker.

### A BROXER'S MINIMUM DUTIES REQUIRED BY LAW (A client is the person or party that the broker represents):

- Put the interests of the dignt above at others, including the broker's own interests.
- Inform the client of any material information about the property or transaction received by the broker.
- Answorthe client's questions and present any offer to or counter-offer from the client, and
- If earlial parties to a rest estate transaction honestly and farty.

#### A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:

AS AGENT FOR OWNER (SELLER/LANDLORD): The broker becomes the property owner's agent through an agreement with the owner, usually in a written listing to sell or property management agreement. An owner's agent must perform the property minimum duties above and must inform the owner of any material information about the property or transaction known by the agent, including information disclosed to the agent or subagent by the bayer or buyer's agent.

AS AGENT FOR BUYER/TENANT: The troker potenties the buyer/tenant's agent by agreeing to represent the buyer, usually through a written representation agreement. A buyer's agent must perform the troker's minimum duling above and must inform the buyer of any material information about the property or transaction known by the agent including information disclosed to the agent by the selector setter's agent.

AS AGENT FOR BOTH - INTERMEDIARY: To act as an intermediary between the pathes the broker must first obtain the written agreement must state who will pay the profest and, in conspicuous belo or underlined print, set to the broker's obligations as an intermediary. A broker who acts as an intermediary.

  - That the buyentenant will pay a price greater than the price submitted in a written offer; and
  - any confidential information or any other information that is party specifically instructs the broker in writing not to disclose unless required to do so by law.

AS SUBACENT. A Idense holder acts as a subagent when aiding a buyor in a transaction without on agreement to represent the buyor. A subagent can assist the buyor but does not represent the buyor and must place the interests of the owner first

#### TO AVOID DISPUTES, ALL AGREEMENTS BETWEEN YOU AND A BROKER SHOULD BE IN WRITING AND CLEARLY ESTABLISM:

- The broken's dulies and responsibilities to you, and your obligations under the representation agreement
- Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated.
