LEGAL DESCRIPTION - 151.34 ACRES

BEING 151.34 ACRES of land, situated in the JOHN W. MONK SURVEY, ABSTRACT 717, and in the THOMAS TAYLOR SURVEY, ABSTRACT 1113, Fannin County, Texas, being all of a called 151.335 acre tract of land, described in a deed to Jonathan Travis Roberts and Valerie L. Roberts, as recorded in Volume 1950, Page 208, Official Public Records, Fannin County, Texas (O.P.R.F.C.T.), and being more fully described by Metes and Bounds as follows;

BEGINNING at a 3/8" iron rod found at the northwest corner of said 151.335 acre tract, on the east line of a called 88.885 acre tract described in a deed to Gerald L. Vaughn, et ux, as recorded in Volume 1484, Page 476, O.P.R.F.C.T., and at the southwest corner of a called 29.176 acre tract described in a deed to Horace Francis Claire as recorded in Instrument No. 2023004778, O.P.R.F.C.T., (described in: Volume 647, Page 446, O.P.R.F.C.T.);

THENCE S 88°57'51" E, along the north line of said 151.335 acre tract and the south line of said 29.176 acre tract a distance of 1165.59 feet to an angle point of said 151.335 acre tract, at the southeast corner of said 29.176 acre tract, and at the southwest corner of a called 17 acre tract described in a deed to Horace Francis Clarie as recorded in Volume 835, Page 87, O.P.R.F.C.T., from which a 3/8" iron rod found bears N 42°09'59" E a distance of 3.41 feet for reference:

THENCE N 89°46'28" E, along the north line of said 151.335 acre tract and the south line of said 17 acre tract, at **1794.58 feet** passing a 3/8" iron rod found at the base of a tree for reference, continuing along said course in all a total distance of 1818.75 feet to a point at the northeast corner of said 151.335 acre tract, at the southeast corner of said 17 acre tract, on the west line of a called 40 acre tract described in a deed to Harry Jenkins Allen as recorded in Volume 891, Page 546, O.P.R.F.C.T., and in County Road No. 2999:

THENCE S 01°15'56" W, along the east line of said 151.335 acre tract, the west line of said 40 acre tract, and the west line of a called 58.12 acre Tract 3 described in a deed to Neil Allen, et al, as recorded in Volume 253, Page 230, Deed Records, Fannin County, Texas, (D.R.F.C.T.), a distance of 2433.55 feet to a 1/2" yellow capped iron rod stamped (DATAPOINT #10194585) set at the southeast corner of said 151.335 acre tract, at the southwest corner of said 58.12 acre Tract 3, and on the north line of a called 64.061 acre tract described in a deed to James D. Cherry as recorded in Volume 1571, Page 61, O.P.R.F.C.T., (described in Volume 588, Page 838, O.P.R.F.C.T.);

THENCE N 89°50'20" W, along a south line of said 151.335 acre tract, the north line of said 64.061 acre tract, and the north line of a called 93.4 acre tract described in a deed to Michael David Sherwood as recorded in Volume 1579, Page 412, O.P.R.F.C.T., at 2428.79 feet passing a 6" wood fence corner post found for reference, continuing along said course in all a total distance of 2476.22 feet to a point at a southwest corner of said 151.335 acre tract, and on an east line of a called 122.249 acre tract described in a deed to Gerald L. Vaughan, et ux, as recorded in Volume 1207, Page 220, O.P.R.F.C.T.;

THENCE N 00°01'04" W, along a west line of said 151.335 acre tract and an east line of said 122.249 acre tract a distance of **1279.39 feet** to a 1/2" iron rod found at an ell corner of said 151.335 acre tract and at a northeast corner of said 122.249 acre tract:

THENCE N 88°52'49" W, along a south line of said 151.335 acre 122.249 acre tract a distance of tract and a north line of sa 444.31 feet to a point at the southwest corner of said 151.335 acre tract, on a north line of said 122.249 acre tract, and at a southeast corner of said 88.885 acre tract:

THENCE N 00°28'31" W, along a west line of said 151.335 acre tract and an east line of said 88.885 acre tract, at **12.10 feet** passing a 6" wood fence corner post found for reference, continuing along said course in all a total distance of 1151.87 feet to the **POINT OF BEGINNING**, containing 6,592,192 Square Feet and/or 151.34 acres of land, more or less.
