

#### **MARKET AREA OVERVIEW**

Holt County is located in the northeastern/ north central portion of Nebraska. It neighbored by Rock County to the west and Garfield and Wheeler Counties to the southwest and southeast respectively. There are about 1,393,478 acres of land in farms, and the average size of each is 1,220 acres. The total market value of products sold was \$453,539,000 in 2020. The top three crops in the county are hay, corn for grain, and oilseeds. 44% of the county's land is devoted to cropland, and 53% is devoted to pastureland. As with Rock County to the west, cattle production has remained the primary agricultural economic driver in Rock County over the past 10-12 years, but productive agricultural land will stay in production for the foreseeable future as there is little-to-no development pressure in Holt County.
