A certain lot or parcel of land situated in Jefferson, County of Lincoln, and State of Maine, bounded and described as follows:

Beginning at the highway near the residence formerly of George W. Benner; thence in a northwesterly direction along the line of land formerly of said George W. Benner to land owned or occupied by H.
