<u>BEGINNING</u> at a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") at the southeast corner of a called 33.976 Acre tract conveyed to Ernest Odom, III in Document Number 2019-4460, at an interior ell corner of the said residue of the 718.049 Acre tract, for the northeast corner of this tract;

THENCE entering the said residue of the 718.049 Acre tract, for division, for the following courses and distances:

S 21 ° 35 ' 49 " E - 459.77 feet to a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") for an exterior ell corner of this tract;

S 21°38'09" E - 460.87 feet to a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") for an interior ell corner of this tract;

S 21°42'12" E - 459.54 feet to a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") for an exterior ell corner of this tract;

S 21°49' 18" E - 457.31 feet to a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") for the southeast corner of this tract;

S 67°46'52" W - 560.40 feet to a point within County Road 320, on the east line of a called 90.506 Acre tract conveyed to Alcoa USA Corp. in Vol. 1291, Pg. 321, for the southwest corner of this tract from which a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952"), for reference bears N 67°46'52" E - 15.11 feet;

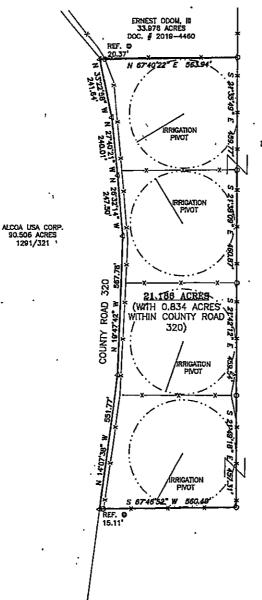
