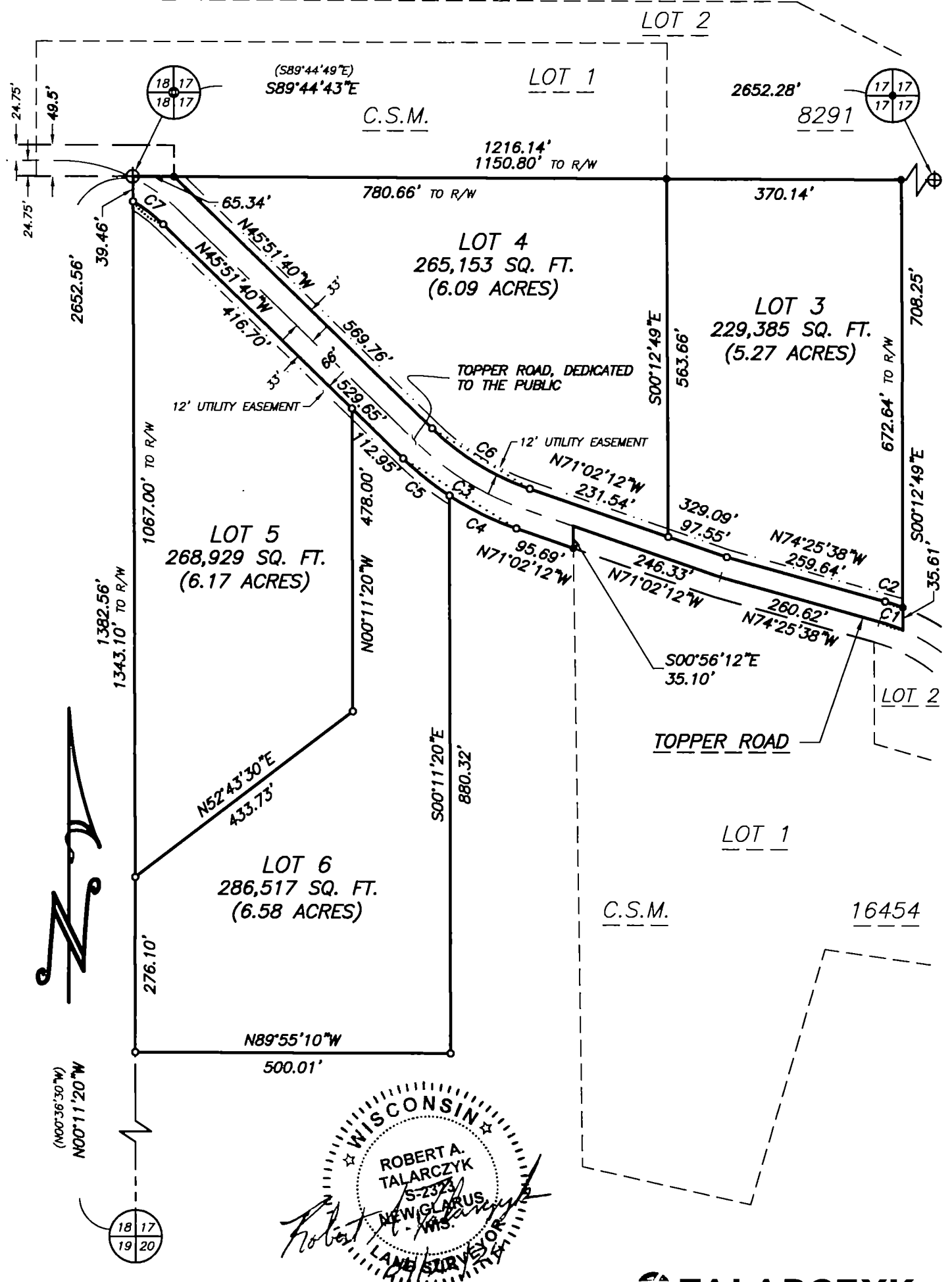


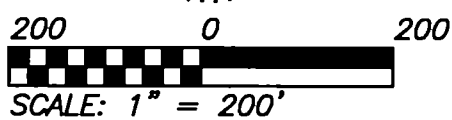

That part of the Northwest and Southwest 1/4s of the Southwest 1/4 of Section 17, Town 6 North, Range 6 East; Town of Blue Mounds, Dane County, Wisconsin, bounded and described as follows: Beginning at the West 1/4 corner of said Section 17; thence S89°44'43"E along the North line of the Southwest 1/4 of Section 17, 1216.14'; thence S00°12'49"E, 708.25' to the centerline of Topper Road; thence Northwesterly, 39.42' along said centerline and the arc of a curve to the left whose radius is 300.00' and whose chord bears N70°39'48"W, 39.39'; thence N74°25'38"W along said centerline, 260.62'; thence N71°02'12"W along said centerline, 246.33'; thence S00°56'12"E, 35.10' to the Southerly right of way line of Topper Road; thence N71°02'12"W along said right of way line, 95.69'; thence Northwesterly, 118.22' along said right of way line and the arc of a curve to the right whose radius is 483.00' and whose chord bears N64°01'29"W, 117.93'; thence S00°11'20"E, 880.32'; thence N89°55'10"W, 500.01' to the West line of Section 17; thence N00°11'20"W, 1382.56' to the point of beginning; subject to a public road right of way as shown and to any and all easements of record.

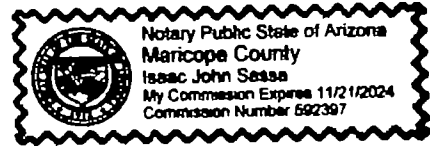
