Posey called 74.66 acre tract described by Instrument 2020-2003985 of the Deed Records of Freestone County, and being in the south line of the Clinton Moody Jr. Tract Two described by Instrument 2301530 of the Deed Records of Freestone County;

THENCE S01°21'12"E 936.74 feet to a set 1/2" iron rod for the southeast corner of this tract, and also being in the east line of said Szymanski 25 acre tract, and in the west line of said Posey 74.66 acre tract, and being the northeast corner of a 10.000 acre tract surveyed this date;

THENCE S88°38'48"W 698.89 feet to a set 60D nail near the centerline of County Road 511 for the southwest corner of this tract, and also being the northwest corner of a 10.000 acre tract surveyed this date, and being in the called east line of the Phillip Jay called 56 acre tract described by Instrument 2024-2405573 of the Deed Records of Freestone County;

THENCE NO1°21'12"W 936.74 feet to a set 60D nail near the centerline of County Road 511 for the northwest corner of this tract, and also being the northwest corner of the said Szymanski 25 acre tract, and being the southwest corner of said Moody Tract Two;

THENCE N88°38'48"E 698.89 feet to the POINT OF BEGINNING and containing 15.029 acres of land of which 0.404 acres of land lie within the county road.
