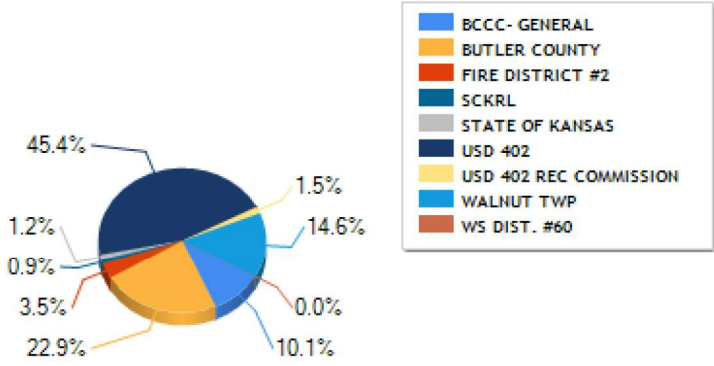

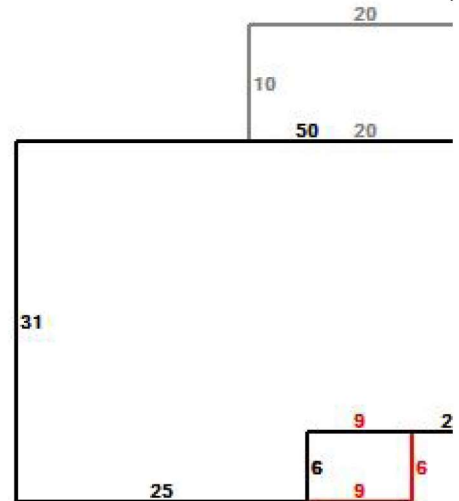

- f. When the Policy is issued, all liability and obligation under this Commitment will end and the Company's only liability will be under the Policy.
